

# Supplementary Terms and Conditions UV Screen, UV Flexo, Pad, UV Dry offset printing inks

#### 1. General Considerations

All deliveries of screen, pad and offset printing inks by A. M. Ramp & Co. GmbH are governed by the General **Terms and Conditions of Sale and Delivery** ("General Terms and **Conditions**") as well as by the following **supplementary terms and Conditions**"). In cases of conflict the Supplementary Terms and Conditions take precedence over the General Terms and Conditions.

## 2. Delivery

- 2.1 Deliveries are ex-works (shipped from A. M. Ramp & Co. GmbH, Lorsbacher Strasse 28, 65817 Eppstein/Taunus, Germany) ICC Incoterms 2010.
- 2.2 For goods with a value of at least  $\in$  1,000.00:
  - a) delivery is made by truck within Germany CPT (agreed destination within Germany) ICC Incoterms 2010;
  - b) for deliveries abroad by truck DAP (agreed destination) ICC Incoterms 2010 with the proviso that the client pays all transportation costs for transport outside Germany;
  - c) for deliveries by air freight FCA (airport agreed place of delivery) ICC Incoterms 2010.
- 2.3 Goods with a value of at least € 3.000,00 are delivered by sea freight FCA (sea port agreed place of delivery) ICC Incoterms 2010.

#### 3. Packaging

- 3.1 The goods are delivered in approved tinplate or plastic containers depending on the shipping method. The shipping container and outer packaging in boxes are always included in the price.
- 3.2 The packaging of hazardous goods for transport as air freight is governed by special regulations, which require the use of special boxes and this makes handling considerably more expensive. For this purpose we apply the following charges:
  - € 100.00 flat rate per delivery
  - € 4.00 extra per box

#### 4. Shipping Documents

The documents that are required for shipping are governed by the relevant regulations at the destination. Individual requirements for preparing the shipping documents may be taken into consideration but are subject to a processing fee of  $\in$  60.00 per delivery.

#### 5. Prices

- 5.1 Unless agreed otherwise, the prevailing valid price list is applicable. All price lists are valid from their printing date. The current price lists replace all earlier editions. A. M. Ramp. Co. GmbH reserves the right to make changes to the price lists; the changes apply subject to clause 5.4 of the General Terms and Conditions, but not to orders that have already been confirmed.
- 5.2 The prices of standard and special inks apply from an order quantity of 24 kg/ltr per ink. The following surcharges per kg/l are made for smaller quantities:
  - 12 23 kg/ltr: € 3
  - 6 11 kg/ltr: € 8
  - 1 5 kg/ltr: € 15 (standard inks only, clause 6 applies to special inks)
- 5.3 Markdowns for deliveries in different sizes of containers are shown in the prevailing valid price list.

### 6. Special Inks

- 6.1 Special inks are available from an order quantity of 6 kg/ltr per shade. Smaller quantities are only available upon request at a price of € 200.00 per kg/ltr.
- 6.2 For special inks we reserve the right on technical grounds to deliver quantity deviations of up to +/-10 % of the quantity actually ordered.

## 7. Minimum Order Value

The minimum order value per delivery is  ${\bf \in 500.00.}$ 

#### 8. Samples

For producing samples of special inks, we charge € 75.00 per sample. The standard quantity per sample is 250 g.
